

GPABC Minutes

April 7, 2009

Meeting called to order at 6:33 p.m. by President Johnny Gardetto.

Opening Statement – Johnny Gardetto

- GPABC Board contact sheet was routed for attendance; if you are on the contact list and want to be removed from receiving e-mail or other notices, please e-mail Johnny.
- Many new sports reps attending this meeting; outgoing sports reps hold voting rights through June 2009 meeting.

March Minutes: Motion made, seconded and unanimously approved Minutes from meeting of March 11, 2009. Minutes are posted on the website, www.greendaleboosterclub.org.

Project selection -- Johnny Gardetto and Gina Wilkins

- Post Prom Event:** Motion made, seconded and unanimously approved to spend \$500 for PCN post-prom event.
- Hockey:** Motion made, seconded and unanimously approved to spend \$1,800 (9 Greendale players @ \$200 each) to reimburse some of Hockey fees (parents paid \$1500 per player this year).

AD Update –Gina Wilkins

- Hockey team:** Because of co-op contract, there may not be enough players for a JV team during the 2009-10 season. Will monitor interest next year and may only field a varsity team until contract expires and new schools can be added to co-op.
- Football Gold C Cards:** Gold C has declared bankruptcy. School is looking for a company with similar card to replace Gold C fund raiser.
- Project Prom:** Junior class is holding a prom preview fashion show on Thursday, April 9th. Tickets are \$5 or \$6 at the door. Proceeds will fund prom events.

- Golf outing and flower sale money will still be receipted for this fiscal year.

Fundraiser / Activity Reports

- Jimmy K's Night** – Annette St. Martin. St. Patrick's Day earned \$104. Next event will be held on April 21st. Because this is not bringing in much revenue and Annette devotes a lot of time to this fund raiser, the officers questioned whether it was worth all the effort. Discussion held on alternatives for this event. Contact Johnny with any ideas on a replacement. Further discussion on continuing this fund raiser will be held at next meeting.
- Flower Sale** – Annette St. Martin. All orders must be placed before school closes for the break on Thursday April 9th, or contact Annette. Order forms are on website or from Annette. \$21 per basket. All flowers will be delivered Mother's Day weekend. Please contact Annette if you have time to help sort and distribute flowers on May 8th or 9th.
- Outdoor Concessions** – Cindy Connell. Cindy distributed the 2009 track concession schedule. Basically, six events need coverage. Teams are assigned and if you need to switch dates, contact Cindy with information on the change. The 2008-09 sports reps are responsible for getting these volunteers.
- Scholarship Committee** – Johnny Gardetto for Jeanine Bly. 32 applications were received and are now being evaluated by the judges. Scholarships – 2 senior girls and 2 senior boys – will be awarded on June 11th.
